Instore Competition Terms and Conditions

1. This Competition is promoted by P&L Hardware (Pty) Ltd (Reg No: 2005/034592/07) (the “**Promoter**”). This Competition is conducted in accordance with the provisions of section 36 read with Regulation 11 of the Consumer Protection Act No. 68 of 2008 (“**CPA**”) as amended from time to time.

- 2. Competition Period**

The Competition will run from the (12th of December 2025) until the (11th of January 2026), both dates inclusive (the “Competition Period”). No entries will be accepted after (11:59pm) on the (11th of January 2026).

- 3. Who Can Participate in the Competition**

You are entitled to participate in this Competition if you are a natural person, 18 (eighteen) years or older, who is either a South African citizen or resident and in possession of a valid identification document. The Promoter reserves the right, at any time, to verify the validity of a Participant's identification document (including but not limited to a Participant's identity and age) and to reject any Participant who has not complied with these terms and conditions. Errors and omissions may be accepted at the Promoter's sole discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

- 4. People Excluded from Participating in the Competition**

Director, Member, Partner, Employee, Agent or Consultant or any other person who directly or indirectly controls or is controlled by the Promoter or Marketing Service Providers in respect of the promotional Competition, or their Spouses, Life Partners, Business Partners or immediate Family Members.

- 5. How to Enter**

On the day of the draw, make a purchase at any P&L Hardware and provide the Cashier with your cell phone number in order to be entered into the lucky draw.

- 6. Number of Entries Per Participant**

Each Participant can only enter the Competition once, no multiple entries per Participant are permitted.

- 7. Entry Fee**

There is no entry fee to participate in the Competition, except for paragraph 5 above.

- 8. The Prize**

- 9. General Terms and Conditions**

If the qualifying criteria are not met, further random draws take place until a valid randomly selected entry meets the eligibility criteria.

through no fault of the Promoter, the Prize will be awarded to the next eligible Winner(s). The Winner(s) may also be published on the Promoter's website only once the Promoter has made successful contact with the Winner(s).

- 9.6. In the event the Promoter is unsuccessful in reaching the winner(s), a new winner(s) is randomly drawn and shall be contacted.
 - 9.7. The Competition is not open to Employees, Family Members of Employees, and/or Representatives of the Promoter's and any Supplier of goods or services in connection with the Competition. The winner(s) will be required to confirm this in the form of a Written Declaration.

 - 9.11. The Participant hereby consents to the Promoter's use and processing of any and all Personal Information in accordance with the Protection of Personal Information Act 4 of 2013 in facilitating the Participant's entry as stated herein.

The Name of the Winner(s) and their pictures may be published on the Promoter's various public and Social Media platforms, including Facebook, Instagram and other P&L Hardware social media platforms, once consent has been provided.

The Promoter cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants of this Competition agree that the Promoter, subject to the prevailing laws, has no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of the Prize, or from participation in this Competition.
 - 9.14. The laws of the Republic of South Africa govern this Competition. If any provision or part of these Competition Rules is deemed void or otherwise unenforceable in law, then that provision or part thereof shall be deemed excluded and the remainder of these Competition Rules shall remain in force. Any violation of these Competition Rules will result in the immediate disqualification of the transgressing Participant from the Competition.
 - 9.15. The Promoter's decision is final, and no correspondence and interaction will be entered into.
 - 9.16. The right of a Participant to any benefit or right conferred / granted because of participating in the Competition will only be fully vested when the Winner has been duly contacted.
